# Food Protection Program 2018 ServSafe Manager Course Certification Schedule

## LEVEL TWO CERTIFICATION IN FOOD PROTECTION

Licking County Health Department is an approved provider in Ohio to administer this level two certification in food protection course. Successfully completing this course, and passing the course examination, will provide the participant with the following certificates: **ServSafe Manager Course Certificate** issued by ServSafe, and a **Level Two Certification in Food Protection** issued by the Ohio Department of Health. The Ohio Uniform Food Safety Code states that all Risk Level III & IV food facilities must have one employee with supervisory and management responsibility who has obtained a Level Two Certification in Food Protection Certificate.

### EXAM DETAILS

The proctored course examination (90 multiple choice questions) will begin at 4pm on the second day. The participant must receive a 75% or higher on the examination to pass the examination, and receive their course certificates. If the participant does not pass the examination, they must re-take the examination at a later scheduled time.

## COURSE REGISTRATION

The cost of this course is \$150. Please complete and submit the course registration form, along with the course fee, to reserve your seat. You can call (740) 349-6535, option 1, to register and pay for the course over the phone. Additional information on course registration submission can be found on the registration form. **No refunds will be issued to registered participants if they do not notify our office within one week of the course start date of their absence.**

## COURSE DETAILS

All courses will be held at Licking County Health Department (675 Price Road, Newark, OH 43055). This is a two-day course, and the participant must successfully attend both course dates to be eligible to take the course examination. Day one of the course is 8-5pm, and day two of the course is 8-4pm. An hour is scheduled for lunch on your own for each course day (noon). A course book, examination answer sheet, and materials to take notes will be provided.
