

New Dashboards were added to our website, providing visual displays of Flu, Communicable Disease, and Community Health Status data.

During 2017, LCHD released an updated Community Health Assessment report. Data describing health risks, disease rates, child and infant health stats, and other indicators of the health status of our residents was included. This information will be used to update our Community Health Improvement Plan in 2018.

LCHD continues to be a leader in public health in Ohio. In 2017 I began my term as President of the Ohio Public Health Association. Other LCHD staff also serve as officers of the Ohio Environmental Health Association, Ohio Society for Public Health Education, and other professional associations and as members of state committees.



### **Health Education**

#### Promoting Healthy Lifestyles Through Education



#### Child Safety Seats Program

completed 66 car seat checks, taught 26 car seat classes, and provided low income residents with 201 free car seats.



#### Tobacco Prevention



promoted smoke-free environments, tobacco cessation and youth tobacco prevention. 56 youth participated in the **stand** youth-led tobacco prevention initiative. The program facilitated bi-monthly Tobacco Use Reduction Network (TURN) meetings for the county.

#### Moms Quit For Two

is a national, evidenced-based smoking cessation program designed to help pregnant women quit smoking and stay tobacco-free. In 2017, Moms Quit for Two served 6 women.

#### Partners in Wellness

provided 1,775 third-grade students in 11 school districts in Licking County with comprehensive health and wellness lessons. The objective of the Partners in Wellness program is to cover all aspects of wellness, including physical, social and emotional health.

#### Worksite Wellness Workshop Event



was held in April; the sixth annual event for the Wellness Coalition's Worksite Wellness Workgroup. In addition, the first Licking County Worksite Wellness Award was presented to two local businesses.

#### Screening and Survivor Support (SASS)

provided free mammograms to 13 women in 2017.
Of those 13 women, two received diagnostic follow-up testing. SASS also provided 19 Licking County breast cancer patients with \$9,500.00 in financial aid.

#### Ohio Healthy Program

offered child care programs the opportunity to train staff, implement wellness policies, engage parents and improve menus. In 2017 LCHD assisted four child care facilities towards designation and helped three child care centers reach designation.



#### Safe Communities

provided motorcycle safety, drunk driving prevention, distracted driving and seat belt safety information to the community. The Safe Communities program participated in 22 community events in 2017.

#### Creating Healthy Communities(CHC)



worked with the Canal Market District (CMD) farmers' market to add Produce Perks to the market which provides a dollar for dollar **ProducePERKS** match to SNAP recipients to purchase more produce. CHC

also assisted the CMD with a tobacco-free public spaces policy.

In the Village of Buckeye Lake, CHC is assisting a group to open a new community center. CHC helped with purchasing supplies for a fitness room and pass a tobacco-free property policy.

CHC also assisted LCHD to add a playground and open use policy for the Health Department's outdoor space's open to the public.

#### Kickin' Ash Splash Event



718 community members attended our annual Kickin' Ash Splash pool party at the Heath City Water Park.

#### Radon Program

promoted the availability of free radon test kits to Ohio homeowners. In 2017, Licking County Health Department conducted outreach activities to increase the publics awareness of radon and promote radon testing in homes.



#### SASS Pink Strides 5K Event

The Pink Strides Trail Run and Wellness Walk was held in September with 68 attendees.

#### Licking County Wellness Coalition

promoted physical activity, healthy eating and worksite wellness. Coalition members met regularly and distribute a monthly newsletter. Three workgroups met monthly: Worksite Wellness, Active Living, and Healthy Eating.

#### Change Gears: Ride a Bike Event



552 Flu vaccines to children

During the 2017-2018 flu vaccination season, staff

traveled to numerous off-site facilities including senior housing, assisted living facilities, public agencies, school districts, health fairs and various businesses to administer the vaccine. In all a total of 22 offsites were provided a flu vaccination clinic.



Sexual health clients

This clinic provides STD testing and education at LCHD by appointment. Most treatments are provided free of charge.



HIV tests

HIV testing is offered to high risk individuals. Other tests may be offered based on symptoms and other criteria. No parental consent is required for testing.

Womens health clients

Breast & Cervical Cancer Project (BCCP) screenings

The Breast and Cervical Cancer Project (BCCP) program provides education, mammograms, pap tests and case management related to breast and cervical cancer in the central Ohio region. Women are eligible for BCCP who meet certain age and income guidelines.

Dental sealants applied

This program provides free dental screenings, oral health education and dental sealants to second, third, sixth and seventh grade students in income qualifying districts.

D. Kintner, CNP at LCHD, is a provider for the Breast and Cervical Cancer Program. Women who meet eligibility criteria of the BCCP program are offered free clinical breast exams, mammograms and PAP testing.

# Other LCHD Programs Public Health in 2017



LCHD's Quality Improvement (QI) principles allowed us to be more efficient and accurate, while providing high quality service to our customers. We improved our immunization clinic scheduling process and reduced

the wait time for an appointment

for our back to school clinics from over 30 days to under five.

Food service operation inspections

Our food service program provided high quality inspect and education to protect county residents from foodborne illnesses. We trained a total 290 participants in our 201 safety courses. Our progran audited by the Ohio Depar of Health with a perfect sco 100 percent.

LCHD's PHEP staff worked with partners from across the public health system, like Licking County EMA and Licking Memorial Hospital, to increase the overall preparedness Jis level of the county. We assisted in the response to the Buckeye Lake **V**floodin'q in July by providing nursing services at a shelter, disseminating information to the public, and conducting inspections in the area to mitigate any potential concerns.
