RE: Mosquito control

The Licking County Health Department is offering the opportunity to contract for mosquito control for the upcoming mosquito season, which typically runs May through October. We offer this service to reduce nuisance mosquito populations and to control mosquito-borne diseases such as West Nile Virus and La Crosse Encephalitis.

The cost of spraying to kill adult mosquitoes will be \$55.00 per application for up to 2 miles of spraying. Each additional mile will be \$28.00. You will have the opportunity to identify the areas you would like sprayed, and you will need to provide access to these areas to our staff and a vehicle. You will also have the ability to determine how frequently you would like spraying to occur. In the past, some facilities have opted for weekly applications when mosquitoes have been consistently present during the evening hours, others choose to only spray prior to special events, or when mosquito populations are high. Our department can deploy mosquito traps in order to determine mosquito population levels upon request.

Any mosquito control program should include the prevention of mosquitoes by eliminating standing water, and/or treating breeding sites with larvicide to control the emergence of adult mosquitoes. Property owners should eliminate containers that can hold water for more than one week to eliminate breeding sites. Any areas that cannot be drained can be reported to our department for larvicide application should you choose to treat these areas.
